WAIVER AND RELEASE FORM OF Little Heroes Karate

I hereby agree to join the Little Heroes Karate (a.k.a. Karate Heroes, LHK) for the term of my membership or an event, and I will comply fully with the rules and philosophy of the Instructors and the LHK. The goals include mental and physical self-development through concentration, self-discipline, fitness, coordination, and respect for others.

Karate is a physical activity. Uncontrolled or careless contact such as punching and kicking a partner is not permitted. Members must realize that in spite of care, precaution, and concern, that accidental injury may occur by the very nature of the activity. Using excessive force or showing disregard for the safety of others in training will result in dismissal. Any student who exhibits behavior, conduct or attitude considered detrimental to the LHK, its instructors and its students will be dismissed. Such exhibition is not limited to actions within the school confines.

Parents are encouraged to observe the lessons. Though not required to stay and observe, parents are asked to stay with minor students until there are "three-in-the-house", that is instructor and two students, or one student plus a family member, etc.

I hereby agree to indemnify and save harmless LHK, Andreas Eros, and appointed instructors and volunteers, against any and all liability, loss, damages, costs, or expenses which they may incur or be required to pay as a result of my (son's or daughter's) participation in the LHK's activities. I further agree not to make claim against any other person or corporation which in turn would make a claim against LHK or its LHK instructors. I further understand that my fees are fully due, whether I participate or not, for any reason during my membership period. A student is considered an active member until a written notice of withdrawal is submitted, at least 10 days in advance of tuition due date. No refund will be made on any unused lessons for any reason whatsoever.

I hereby assume all risk of my son's or daughter's participation in this activity. And I also understand that karate students will be exhorted to go harder, jump higher, take chances physically, and more in accord with a highly energetic activity such as a martial art. And that there is a definite risk of injury, accident, being hit or kicked, thrown, falling and more that can be serious and include bruises, lacerations, broken bones, internal injury, death and not limited to these. I understand that, in addition to fees, there may be required costs such as belt testing, special events, and protective gear.

I further agree that this agreement* and addendum will continue in force in all its purposes, meanings, and obligations during any and all parts of my participation in the future with LHK. This specifically includes renewal periods after an existing period upon enrollment has ended as well as future events. This agreement and addendum form will remain in effect as well as the financial obligations of the renewal period upon any payment towards the next period of enrollment. The LHK will remind the student (and parents if applicable) of an upcoming renewal date. In case of an adult parent or guardian signing this agreement, it is further understood that this signer is obligated to all conditions of the agreement and amendments and accepts the responsibility for all actions of the minor student for whom the agreement is being made and will carry out all obligations of the agreement as if the adult signer were a student of the LHK.

*"Agreement" is defined to include all waivers, releases, addenda, amendments and principal agreements made between the signer and the LHK.
